Section A: Instructions to Tenderers:

**Limited Period Contract for the
technical service and equipment rental of a Public Address system
(PA system) at the
Ministry for Foreign Affairs**

The Ministry for Foreign Affairs requires the technical service and equipment rental of a Public Address System (PA System) for Ministerial events and other occasions throughout the year. Normally, the location of the event will be at Palazzo Parisio, Ministry for Foreign Affairs, Merchants' Street, Valletta. The system might be used inside one of the Ministry's halls or the courtyard. Events may be organised even after office hours (e.g. in the evening).

Technical Specifications

Minimum PA System equipment required:

1. Audio mixer with at least six (6) inputs
2. Loudspeakers with stands (size of hall of up to 150 guests)
3. Loudspeakers with stands (size of hall of up to 50 guests)
4. Podium microphones
5. Gooseneck table microphones
6. Cordless microphones (including batteries)

The above equipment should be inclusive (but not limited to) of cabling, receivers and dome trunking to cover any wires as may be deemed appropriate;

NB: Unless otherwise agreed to between the Ministry and the selected service provider, electricity supply will be supplied by the Ministry.

Minimum audio technician / engineer services required:

1. The audio technician may be called for the service within 24 hours.
2. The audio technician shall test the system in the presence of the Officer in Charge of the event in order to confirm that its performance satisfies the requirements for the said event.
3. The technician is required to be on site during the event to operate the audio equipment and offer any technical support that may arise.
4. The technician may be required also on a Sunday or Public Holiday if the need arises. Therefore a separate rate per hr is to be included in the Schedule of prices.

Assembling/dismantling and transportation/carriage costs are to be included in the quotation.

Note:

The Ministry reserves the right to order other ancillary audio systems not included in this list.

3. Quotes must be provided in Word, Excel, pdf or jpg formats. When links are provided for Technical Specifications, these should lead to the website and must not require the downloading of any programs, the creation of accounts or other functions. Other formats will NOT be considered.
4. Please note that **ALL** quotes must include the Reference number together with the name of item being requested. In cases, where this information is not included, the Contracting Authority reserves the right NOT to consider the quote.

Quotes can be sent either through email or brought by hand, in which case they should be inserted in the **Tender Box found at the Directorate Corporate Services, Ministry for Foreign Affairs, Level 4, 331, Allied House, St Paul Street, Valletta. Quotes can be brought by hand from Monday to Friday between 8.00 am and 12.00 pm only.** Offers received via E-mail will be inserted in a sealed envelope and posted in the respective box.
6. Quotes must be valid for a minimum of **90** days.
7. **Since this call is a limited period contract, the awarded contract shall be valid up to the maximum of €6,000 excluding VAT**
8. **Delivery costs must be included in all received quotes.**

- Prices are to include delivery costs. The Bidder is advised to contact Valletta Local Council to familiarise self with any charges, permits and any other obligations that are to be borne by the contractor to effect delivery. The Contracting Authority shall not be charged with any other charges on delivery which were not reflected in the respective bid.

Tenderers not registered with the VAT authority in Malta, must **still** include in their financial offer any VAT that the contracting authority may have to pay either in Malta or the country where the tenderer is registered irrespective of the reverse charge mechanism. The financial offer will be considered as the total financial cost to the contracting authority including any VAT that may have to be paid not through the winning tenderer. Except as may otherwise be provided for in the contract, no payment will be made for items which have not been costed.
11. All Suppliers/contractors are advised to bid their rates and prices on the appropriate Schedule of Rates provided above. No offers are accepted if are found not in accordance with or deviate from the original Schedule of Rates provided with this Advert.
12. If the tenderer offers a discount, the discount must be absorbed in the rates of the Bill of Quantities/Financial Statement. The prices for the contract must include all of the works to be provided. The prices quoted are fixed and not subject to revision or escalation in costs.
13. Given information, specifications and manuals must be in English or Maltese. Tenderers submitting information, specifications and manuals in other languages only will be automatically disqualified. (where applicable)
